How to leave a legacy to VOCAL

A legacy is a specific gift in your will. It could either be a sum of money, an item or it could be a share of the value of your estate after all bills have been paid and all considerations to family and friends have been honoured.

If you would like to add a gift to VOCAL in your existing will, you can use a codicil. Adding a codicil to your will means there is no need to change the terms of your current will. It simply adds a new instruction. In general, if the change you wish to make is quite small or straight forward, you can use a codicil.

However, if the change is more significant or complicated, it is advisable to make a new will.

Leaving a gift to charity has the added bonus of being exempt from tax, so it may reduce the amount of inheritance tax that is due from your estate.
